98.1 KKFM's "WIN TICKETS TO CURIOSITY CON" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station KKFM("Station"), owned and operated by Cumulus Media Colorado Springs, 6805 Corporate Drive, Suite 130, Colorado Springs, CO 80919, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

Eligibility.  - (iv) <u>Text</u>: Send a text message with the keyword Curiosity to 719-715-0981 when prompted during the Contest Period. All entries must be received by 4:59pm MST on January 12, 2023 to be eligible for the Grand Prize drawing. Standard text messaging rates, as established by an individual's wireless carrier, may apply, and Station assumes no responsibility for any fees or charges incurred for and associated with any text message sent to or from Station. Any and all fees arising out of the transmission of a text message shall be the sole responsibility of the entrant. Limit one (1) entry per person per phone number. Multiple participants are not permitted to share the same telephone number. Any attempt by any participant to submit more than one (1) entry by using multiple/different telephone phone numbers, identities, or any other methods will void that participant from further participation in the Sweepstakes.
- 4. **Winner Selection.** On or about 3:30pm MST on each day of the contest period, Station will select one) entry for the Grand Prize in a random drawing from among all valid entries received by Station during the that days Contest Period. The winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification and forfeiture of the prize.

- 5. Verification of Potential Winner. - 7. Entry Conditions and Release.
