KKFM'S "Mom'S ROCK WITH LUISA GRAF" CONTEST OFFICIAL RULES

Eligibility. - 2. Contest Period. The Contest will begin at 12:01am MT on April 28th, 2025 and will run through 3:59pm MT on May 7th, 2025 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.

- 4. (iv) <u>Text</u>: Send a text message with the keyword MOM to 719-715-0981 when prompted during the Contest Period. All entries must be received by 11:59pm MST on May 7, 2025 to be eligible for the Grand Prize drawing. Standard text messaging rates, as established by an individual's wireless carrier, may apply, and the Station assumes no responsibility for any fees or charges incurred for and associated with any text message sent to or from Station. Any and all fees arising out of the transmission of a text message shall be the sole responsibility of the entrant. Limit one (1) entry per person per phone number. Multiple participants are not permitted to share the same telephone number. Any attempt by any participant to submit more than one (1) entry by using multiple/different telephone phone numbers, identities, or any other methods will void that participant from further participation in the Sweepstakes.
- 5. **Winner Selection.** At 4:15pm MT on May 7th, 2025, Station will select one (1) entry for the Grand Prize in a random drawing from among all valid entries received by Station during the Contest Period. The winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to

respond to the initial verification contact within three (3) days of notification will result in disqualification and forfeiture of the prize.

- Verification of Potential Winner. THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS 6. IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination.
